Punctuality

Please arrive at least 15 minutes before your scheduled treatment for check-in and any possible clothing changes. If you happen to be late we offer two choices.

- You may shorten your treatment because of time constraints and other clients' schedules.
- You can reschedule your appointment with a \$25 cancellation fee to accommodate our professionals.

In case of prepaid vouchers your single treatment will be forfeited. If you would like to reinstate that treatment, a fee equal to the single treatment will apply.

Cancellation Policy

Drops of Beauty Medical Spa understands that you may have to cancel an appointment sometimes. However, we require that a 24-hour notice must be given. Failure to do so will result in a \$25.00 charge of your scheduled treatment to your credit card.

Payments

Our available payment options are credit and debit cards (including American Express), cash, Discover and gift certificates.

Gift Certificates

Gift Certificates are available at the reception desk or through the med spa coordinator at the time of your consultation. Gift Certificates are required at the time of service and must be redeemed within one year from the date of purchase.

Tipping and Gratuity

Refunds

No refunds will be given on products, services, and gift certificates. This includes prepaid services including botox and fillers, permanent makeup, and all retail and all services.

Exchange of Series, Packages and Programs

When purchasing a series of treatments or bundled packages, a discounted rate is given at the time of purchase; payment must be made at the beginning of treatment. The series are non-refundable, and non-transferable. However, should you choose during your series to opt for a different service any remaining balance may be applied to a different treatment. When canceling a series, we deduct full price of used services.

Arbitration Agreement

Article 1: Agreement to Arbitrate: It is understood that any dispute as to medical malpractice, that is as to whether any medical services rendered under this contract were unnecessary or unauthorized or were improperly, negligently or incompetently rendered, will be determined by submission to arbitration as provided by state and federal law, and not by a lawsuit or resort to court process except as state and federal law provides for judicial review of arbitration proceedings. Both parties to this contract, by entering into it, are giving up their constitutional right to have any such dispute decided in a court of law before a jury, and instead are accepting the use of arbitration.

Article 2: All claims Must be Arbitrated: It is also understood that any dispute that does not related to medical malpractice, including disputes as to whether or not a dispute is subject to arbitration, will also be determined by submission to binding arbitration. It is the intention of the parties that this agreement bind all parties as to all claims, including claims arising out of or relating to treatment or services provided by the health care provider including any heirs or past, present or future spouse(s) of the patient in relation to all claims, including loss of consortium. This agreement is intended to bind any children of the patient whether born or unborn at the time of the occurrence giving rise to any claim. This agreement is intended to bind the patient and the health care provider and/or other licensed health care providers or preceptorship interns who now or in the future treat the patient while employed by, working or associated with or serving as a backup for the health care provider, including those working at the health care provider's clinic or office or any other clinic or office whether signatories to this form or not.

All claims for monetary damages exceeding the jurisdictional limit of the small claims court against the health care provider, and/or the health care provider's associates, association, corporation, partnership, employees, agents and estate, must be arbitrated including, without limitation, claims for loss of consortium, wrongful death, emotional distress, injunctive relief, or punitive damages.

Article 3: Procedures and Applicable Law: A demand for arbitration must be communicated in writing to all parties. Each party shall select an arbitrator (party arbitrator) within thirty days and a third arbitrator (neutral arbitrator) shall be selected by the arbitrators appointed by the parties within thirty days thereafter. The neutral arbitrator shall then be the sole arbitrator and shall decide the arbitration. Each party to the arbitration shall pay such party's prorated share of the expenses and fees of the neutral arbitrator, together with other expenses of the arbitration incurred or approved by the neutral arbitrator, not including counsel fees, witness fees, or other expenses incurred by a party for such party's own benefit.

Either party shall have the absolute the right to bifurcate the issues of liability and damage upon written request to the neutral arbitrator.

The parties consent to the intervention and joinder in this arbitration of any person or entity that would otherwise be a proper additional party in a court action, and upon such intervention and joinder any existing court action person or entity shall be stayed pending arbitration.

The parties agree that provisions of state and federal law, where applicable, establishing the right to intrude evidence of any amount payable as a benefit to the patient to the maximum extent permitted by law, limiting the right to recover non-economic losses, and the right to have a judgement for future agree that the Commercial Arbitration Rules of the American Arbitration Association shall govern any arbitration conducted pursuant to this Arbitration Agreement.

Article 4: General Provision: All claims based upon the same incident, transaction or related circumstances shall be arbitrated in one proceeding. A claim shall be waived and forever barred if (1) on the date notice thereof is received, the claim, if asserted in a civil action, would be barred by the applicable legal statute of limitations, or (2) the claimant fails to pursue the arbitration claim in accordance with the procedures prescribed herein with reasonable diligence.

Article 5: Revocation: This agreement may be revoked by written notice delivered to the health care provider within 30 days of signature and if not revoked will govern all professional services received by the patient and all other disputes between the parties.

Article 6: Retroactive Effect: If the patient intends this agreement to cover services rendered before the date it is signed (for example, emergency treatment) patient should **Initial Here____**. Effective at the date of first professional services.

If any provision of this Arbitration Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and shall not be affected by the invalidity of any other provision. I understand that I have the right to receive a copy of this Arbitration Agreement. By my signature below, I acknowledge that I have received a copy.

NOTICE: BY SIGNING THIS CONTRACT YOU ARE AGREEING TO HAVE ANY ISSUE OF MEDICAL MALPRACTICE DECIDED BY NEUTRAL ARBITRATION AND YOU ARE GIVING UP YOUR RIGHT TO A JURY OR COURT TRIAL. SEE ARTICLE 1 OF THIS CONTRACT.

Consent for Dermal Filler and PRP Injections

I understand that I will be injected with one or multiple of the following fillers: Restylane, Refyne, Defyne, Restylane Silk, Restylane Lyft, Radiesse, Voluma, Juvederm, Volllure, Volbella, Beloterro hyaluronic acid dermal fillers, or PRP (Plasma).

Dermal fillers and PRP have been FDA approved for use in cosmetic treatments for moderate to severe wrinkles around the nose and mouth. I understand this treatment is temporary, and re-injection is necessary after about six months. It has been explained to me that other temporary and more permanent treatments are available.

The following complications may occur with the dermal filler injection procedure:

- 1. Risks:I understand there is a risk of bruising, redness, swelling, pain at the injection site, tenderness, itching, allergic reaction, and raised bumps of skin (nodules). These symptoms are usually mild and typically last a few days but can last up to a few months. In rare cases, bruising can last several months and even be permanent.
- 2. Infection: Post treatment bacterial, viral and/or fungal infections can occur which in most cases are easily treatable but in rare cases a permanent scarring in the area can occur.
- 3. Effectiveness: Treatment results can last anywhere from 4-6 months up to one year.
- 4. Treatments: I understand more than one injection may be needed to achieve a satisfactory result.
- 5. Allergic Reactions: In rare cases, there may be an allergic reaction to the injection.
- 6. There is a risk of scarring.
- 7. There is a very rare and small risk of vessel occlusion, dermatitis cellulitis and tissue necrosis.
- 8. I will follow all aftercare instructions as it is crucial I do so for healing.
- 9. Drops of Beauty provides complimentary numbing prior to administering fillers, please advise your technician prior to procedure if you are allergic to any numbing agents (lidocaine, tetracaine, benzocaine or privocaine). In addition, most dermal fillers contain the anesthetic lidocaine. If you have any allergies to lidocaine or any of the other numbing agents, please inform your technician prior to the procedure.
- 10. Our office policy to retreat (add or dissolve filler) is a minimum of two weeks post injection. We cannot provide a retreat to the area before two weeks.
- 11. As dermal fillers are not an exact science, there might be an uneven appearance of the face with some areas more affected by the fillers than others. In most cases this uneven appearance can be corrected by more injections in the same or nearby areas. However, in some cases this uneven appearance can persist for several weeks or months. On rare occasions, you may be severely bruised and/or severely swollen post treatment, we do not recommend any special events directly post filler procedures.

This list is not meant to be inclusive of all possible risks associated with dermal fillers as there are both known and unknown side effects associated with any medication or procedure. *Fillers should not be administered to a pregnant or nursing woman*.

The number of units injected is an *estimate* of the amount of fillers required to add volume to the skin and give the appearance of a smoother face. I understand there is <u>no guarantee</u> of results of any treatment and the regular charge applies to all subsequent treatments and we can not provide refunds after injections.

I understand and agree that all services rendered are charged directly to me and that I am personally responsible for payment. I further agree in the event of non-payment, to bear the cost of collection, and/or court cost and reasonable legal fees, should this be required. By signing below, I acknowledge that I have read the foregoing informed consent and agree to the treatment with its associated risks. I hereby give consent to perform this and all subsequent dermal filler treatments with the above understood. I hereby release the doctor, the person injecting the filler and the facility from liability associated with this procedure.

Pre and Post Filler Instructions

Pre Filler Instructions

- 1. If you are prone to cold sores, please inform the front desk personnel (at the time of your appointment) or the nurse or doctor on duty.
- 2. Please come in for your dermal filler appointment with a clean face (i.e. no makeup).
- 3. No ASA (Aspirin), Ibuprofen, Vitamin E, alcohol, or any blood thinning agents within 48 hours of procedure.
- 4. No flying for 48 hours after procedure.
- 5. Do not go in for treatment if you have any infections.
- 4. Do not go in for treatment if you have severe allergies or you have a history of allergic reactions to gram-positive bacterial proteins.
- 5. All dermal fillers should be used with caution in patients on immunosuppressive therapy, or therapy used to decrease the body's immune response, as there may be an increased risk of infection.
- 6. The safety of dermal filler injections for use during pregnancy, in breastfeeding females, or in patients under 18 years has not been established.
- 7. We recommend waiting two weeks after all dental work (dental cleaning included) before getting Botox/Dysport due to a higher risk of infection.

Post Filler Instructions

- 1. Immediately after your dermal filler procedure, you can expect redness, swelling, tenderness, or an itching sensation in the treated area. This is a normal result of the injection. The discomfort is temporary, and generally disappears in a few days.
- 2. Rest and drink a lot of water.
- 3. Use frozen peas or corn (loose) in a Ziploc bag. The goal is cold without pressure.
- 4. During the first 48 hours do not massage unless instructed to do so by the nurse or doctor.
- 5. It is acceptable to use Aspirin or Ibuprofen for discomfort.
- 6. Lay a cold banana peel, using the inner side of the peel, directly, on any bruises.
- 7. Eat raw pineapple to reduce bruising.
- 8. Use Homeopathic Arnica gel, topically, and Arnica Montana (30C), pellets, orally. Apply the gel as often as possible to affected areas. Take 4-5 pellets, under tongue, 4-6 times per day. Use the same day before treatment and directly after treatment and for the weeks following treatment, until pain, swelling, bruising and discomfort have all subsided. Both the topical and oral work in conjunction to reduce healing time and to shorten the duration of bruises. You can get these from Sprouts or Whole Foods.
- 9. If you have had a lip enhancement procedure, avoid puckering your lips for the first two days after treatment, avoid kissing.
- 10. Do not use makeup until the day after the procedure.
- 11. Try to sleep on your back, in a slightly reclined position (use pillows to prop yourself up, to avoid rolling over), for 1-2 weeks following treatment. Dermal Fillers can move if you sleep on your face or on your side.
- 12. After 7-14 days you can go back to your normal routine.
